Remember: Be civil, be brief, tell your story. The reps are rarely going to look at links. If there is information that is important, tell them in the email. As we all know from writing class, put the most important information first. Catch their eye, then tell them more.

- Bills going up

Write about your rights

- Choice
- Property
- Privacy
- Health
